## Delegate Terms and Conditions

---

These terms and conditions apply to the Energy Networks Conference and Exhibition 2026 (**Event**). ## Delegate Registration

---

All delegate applications are handled in accordance with these terms and conditions. Delegates are required to register for Event attendance via the delegate registration link in the summary of key terms and dates set out above.

The delegate may elect to pay at the time of booking or request ENA to issue an invoice for payment.

Registration fees must be paid in full prior to attending the Event. Once payment has been received by ENA, an email confirmation and receipt will be provided. If payment is not made at the time a registration is lodged, then registration will be deemed provisional, and ENA reserves the right to cancel or otherwise deal with such registrations in its absolute discretion.

## Registration Options

---

There may be various registration options available to a delegate wishing to register their attendance at the Event. Please select carefully to ensure the correct registration option(s) is selected, as not all registration options will be available for purchase during the Event dates.

Registration options and fees (including early bird registration fees, standard registration fees, and final round registration fees) are published on the Event website (linked in the summary of key terms and dates set out above) and may change from time to time at the absolute discretion of ENA, provided that the amended registration options and fees will not apply to registrations made prior to the amendment.

## Cancellation of Delegate Registration

---

ENA reserves the right to levy an administration fee for any registration cancellations in accordance with this part. For cancellations received in writing by 5:00pm AEDT on 29 January 2026, being the day prior to the commencement of the late registration period, (as set out next to Event dates in the summary of key terms and dates set out above), a full refund will be given less an administration fee of 20% of registration fee. No refunds will be issued for cancellations received after 5.00pm AEDT on 29 January 2026 to the commencement date of the Event. You acknowledge that these refund terms are reasonable having regard to ENA's reliance on participation numbers in arranging the Event.

Should you be unable to attend the Event, then a substitute delegate or attendee is welcome at no extra charge on the condition that ENA is notified in writing by 5.00pm AEDT on the 29 January 2026 (being the day prior to the commencement of the late registration period). Any request for substitution of delegates or attendees after this date will incur an administration fee of \$55. ENA reserves the right to request photographic identification before admitting a delegate to the Event.

## Early Bird

---

Early bird registration closes on 11 November 2025. If you register for the Event and pay the early bird registration fee in full prior to 12 November 2025, then the early bird registration fee will apply. If you register for the Event after 11 November 2025, then you will not be eligible for the early bird registration fee. If you register for the Event prior to 12 November 2025, but fail to pay the early bird registration fee to ENA prior to 12 November 2025, the standard registration fee will apply to your registration.

## Payment

---

Registration fees can be paid through the registration portal using Visa or Mastercard. If you pay by Visa or Mastercard, a credit card surcharge of 3.1% will apply to the transaction. All amounts are to be made in Australian dollars and include GST. A tax invoice will be provided with your confirmation email.

Alternatively, to pay by Electronic Funds Transfer (EFT), request a tax invoice through the registration portal. That tax invoice will be immediately payable upon receipt by you. If you fail to make payment of the invoice on time, your registration may be cancelled on notice. All EFT payments must be received no later than 28 days prior to the commencement date of the Event. Please indicate the event "EN26", the participant's name, and the invoice number on all payments. Please note that payments made by bank transfer could be subject to fees payable to your local bank. All costs relating to an EFT payment are to be borne by you.

**From Tuesday 2 February 2026, only payment by credit card will be accepted.**

Full payment of the registration fee applicable to your registration is required for delegates to access the Event.

As a global company with our headquarters in Geneva, our merchant facility is located in Switzerland. In the unlikely event when an additional fee is charged, either as a result of an international transaction fee or a charge made by your bank, we will arrange the necessary refund of that fee. ## Code of Conduct

---

Subject to applicable law (including the Australian Consumer Law in Schedule 2 of the *Competition and Consumer Act 2010 (Cth)* (**Australian Consumer Law**)), ENA reserves the right in its absolute discretion (acting reasonably) to prohibit entry of any person to an Event or cause any person to be ejected from an Event if that person engages in behaviour that ENA deems to be inappropriate, unsafe, unacceptable, or unreasonable by ENA staff and/or its agents and others working under its authority. Any delegate who violates these delegate expectations may be asked to leave the event without refund.

## Name Badge Policy

---

To make any changes to a badge, the original participant must provide written permission and full contact details of the substitution. If a badge is lost or forgotten onsite, a reprint can be requested for an administrative fee of \$80 after identity verification.

## Program

---

ENA reserves the right to change or alter the published program at any time. In such an event, ENA will notify you of those changes and use reasonable endeavours to ensure a program of equivalent or superior standard is provided. Unless the changes to the program are a result of a Force Majeure Event, you will have the right to cancel your registration within 5 days after receiving notice of a significant change to the program from ENA.

## Rescheduling the Event

---

Subject to applicable law, including the relevant provisions of the Australian Consumer Law, in the event that ENA determines to reschedule the Event, ENA will provide you with notice of the rescheduled date as soon as is reasonably practicable. You may cancel your registration and receive a full refund of the registration fee paid to ENA within 30 days after you receive notice from ENA of the rescheduled date. If you do not cancel your registration within 30 days, the terms set out under cancellation of delegate registration above will apply.

## Event Cancellation

---

Subject to applicable law, including the relevant provisions of the Australian Consumer Law, in the event that ENA determines to cancel the Event or program, the liability of ENA will be limited to a refund of the registration fee paid. ENA will provide you with notice of the cancellation as soon as is reasonably practicable.

To the fullest extent permissible under law, ENA's liability is limited to your registration fee paid and ENA will not be liable for any damage, loss or additional costs arising out of the cancellation for any reason, including but not limited to indirect or consequential loss or damages such as travel costs, accommodation costs or any other costs or expenses whatsoever.

If you are travelling to attend the event, you may be subject to and should review the terms and conditions relevant to any services that you obtain in order to do so (including but not limited to any terms and conditions of relevant accommodation providers or airlines) before engaging those services.

ENA recommends that you obtain travel, health, and accident insurance (as applicable) before you depart for the conference.

ENA reserves the right to cancel or vary social functions if minimum numbers are not reached. Due to commitments to catering, we cannot refund social functions and any additional ticket cancellations less than 60 days prior to the conference.
